# You Cover WHAT? The Allure of Vintage Race Cars

Hagerty loves to say, "Yes!" That's why we want you to feel comfortable calling us with some of your more unusual requests. We've seen it all! What it really comes down to is this: Hagerty loves cars! We love old cars, new cars, trucks, motorcycles, tractors and even the occasional tank.

Something that a lot of collectors really seem to love right now is vintage race cars. And many people are surprised to find that we do, indeed, offer coverage for vintage race cars. Even ones that still see an occasional race! Some of the cars we've seen have an impressive pedigree and were raced or built by the "who's who" of the racing world. Some have broken speed records. Some are streamlined and look fast sitting still. Others look like unlikely objects of desire (see "Old Yeller" in this issue). But make no mistake, they are a very popular part of the collector vehicle world.

Of course, no coverage applies while a vehicle is practicing, qualifying for or participating in races on racetracks or closed courses. Ditto for races on public roads where legal speeds

are openly exceeded.

So, what does qualify for coverage? Hagerty offers coverage for vintage race cars - those cars that are generally pre-1980 (that '95 BMW that's all built up for weekend club or drag racing just won't cut it!). They are most often "dedicated race cars," or not used on the street. Occasionally, a vintage race car is also street legal, so be sure to ask us if you have a question about appropriate coverage.

Hagerty can provide coverage for:

- Pre and post-race on-track parade laps
- Race/competition/exhibition preparation activities that occur outside an event's location (such as an engine check-up at an auto service shop)
- Club tours and legal speed road rallies on open public roads
- Losses that occur while the vehicle is in the paddock area on display, but not being prepped for a race (a paddock area does not include entrance or exit ramps)
- Coverage for damage that occurs while the vehicle is being trailered from one location to another (see "Trailer Trauma" in this issue)

# Old Yeller: The story of a junkyard dog.

Jim Edwards has an impressive collection of vehicles. One of the prizes of his collection is Old Yeller #1, a car with a significant racing pedigree.

This pieced-together car earned its nickname after the mongrel yellow dog in the popular Disney film of 1957. The story is that Old Yeller #1 was built around 1954 in a barn near Phoenix, Ariz., by Dick Morgensen, a legend in the racing world. It was constructed from junkyard parts – a Plymouth 6-cylinder Buick nailhead engine, a 1938 Ford front end, fenders from a '47 Chevy pickup. This "Morgensen Special" was no beauty, and it was a beast on the track.

From Morgensen, the car found its way to mechanic/driver Max Balchowsky and driver Eric Hauser. Old Yeller #1 had 16 major wins in the years between 1955 and 1960, in places like Pomona, Palm Springs and machine guns on the nose!), but ended its career crashing off of a rail and careening down a steep bank. It was found years later and resurrected. Those that knew the car most intimately, including Eric Hauser and Dick Morgensen, all signed off that this was the legendary Old Yeller #1 – apparently, once you knew it, it made a lasting impression.

Like Jim Edwards says, "Without Old Yeller #1, there wouldn't have been an Old Yeller #2, or 3, or Old Yeller #9." This is the car that started a dynasty, proving that sheer will and a little ingenuity can beat the bank. "It didn't have a lot of sophistication in the chassis or brake system," says Edwards. "It did have raw horsepower and torque."



Laguna Seca. And it wasn't just beating rundown cars and inexperienced drivers. It was beating the best drivers and cars out there – Caroll Shelby, Phil Hill, Bob Bondurant in their Ferraris and Maseratis were beat by Old Yeller #1 in its day.

There are more stories about Old Yeller #1 than time to tell them. It went through many incarnations (including a set of dummy

When Edwards takes Old Yeller out for a race or rally, he always encounters people who "knew" it. He says he can count on someone approaching him, tears in eyes, saying, "I thought I'd never see this car again!" It brings back memories of incredible feats and unbelievable innovation, of a time when anything was possible. And that is what makes vintage race cars so attractive to collectors.



### WHAT DID YOU SAY?

### "SHAVED"

Any extending body parts or chrome have been removed (such as door handles or body trim) and smoothed over to look as though they were never there.



### "FRENCHED"

Certain parts, such as headlights or taillights, have been recessed and smoothed into the body.



### "TUBBED"

Body and rear frame are modified to accommodate extra-wide tires that don't extend past the fenders.
